### Overview of Public Input on Solutions Memorandum

- ▶ The project team shared a summary of the public open house, which also includes detailed responses. Respondents were generally supportive of the project presented.

### Feedback from Advisory Committee on Preferred Plan Memorandum

- ▶ Make clearer that signage and other wayfinding elements are part of the proposed bikeways
- ▶ Potential transit service between Lakeview and Klamath with DHS and BTS is being discussed; BTS is receiving STIF funding to provide service outside of its typical boundary.
- ▶ People for Bikes is another funding source to consider.
- ▶ Can a breakdown of responsibility between ODOT and Town regarding project costs be provided? A typical match could be included or where partnerships between ODOT and Town are applicable can be made clear.

## Next Steps

- ▶ Finalize Preferred Plan Memo
- ▶ Start developing Draft TSP – aiming for a submission at end of June
- ▶ Last Advisory Committee meeting in Summer 2021
- ▶ Start discussions about the adoption hearing – plan for after July 1<sup>st</sup> (Town fiscal year start); Council meets the 2<sup>nd</sup>/4<sup>th</sup> Tuesdays of each month
